#### FORMULATION ADVICES: Pilot - 2 kg - Trimix - Rotor Stator

Weigh ingredients of phase A and heat the phase to 80°C under agitation into a tank. Weigh ingredients of phase B in a beaker and heat to 80°C with a hot water bath. Then add phase C and D into phase B, and mix with a spatula. Emulsify phase (B+C+D) putting into phase A under agitation at 3000 rpm (Trimix). Stop the rotor stator and maintain the other agitations. Cool down to 60°C and put under vacuum. When the formula reaches 30°C break the vacuum and add phase E.
