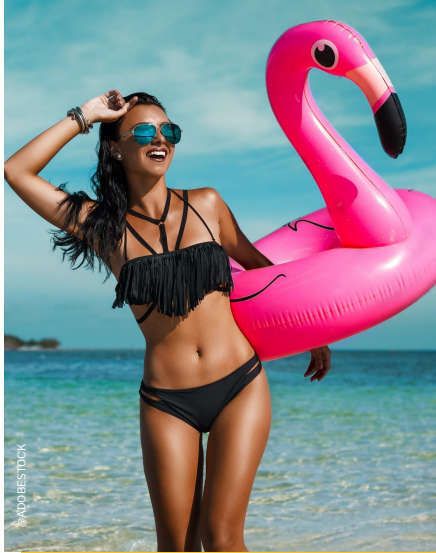

Weight all phase A ingredients together. Heat phase A up to 85°C until the total solubilization of the filter in powder (water bath). Mix until it gets homogeneous. Cool down phase A at RT. Blend phase B ingredients together. Once the phase A reaches RT, add phase B into A.
