Process 200g at laboratory scale

Prepare phase A in a beaker. In an other beaker weigh ingredients of phase B then disperse in phase B Solagum AX and mix gently with a spatula. Pour phase A in phase B all at once and homogeneize under Rotor Stator at 4000 rpm for 4 minutes. Then stir gently under Anchor for 10 minutes ans add ingredients of phase D one by one.
